

Turn the power off at the circuit breaker before installing this device.

It is recommended that a qualified electrician performs this installation. Make sure to turn off the circuit breaker or fuse(s) and make sure power is off before wiring the device.

Use copper wire only. No Aluminum.


INPUT: Use wires with minimum rating of 75° C (167° F)



WIRING DIRECTIONS

- 1. Remove the wall plate.
- Remove existing switch from wall box and prior to disconnecting wires, identify the wires and label as needed.
- 3. Remove wires from existing switch.
- 4. Follow the diagram below to connect the LDS-1P

Fine tuning.

- 1. Set dimming slider to lowest level before adjusting.
- Use this dial to adjust the lowest dimming level for bulbs that flicker. (Low-End)

The dimming slider has an off position when you move the slider all the way down. There will be a noticeable click when you slide to turn on or off.
